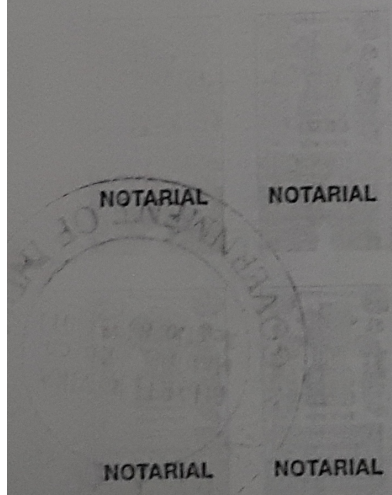
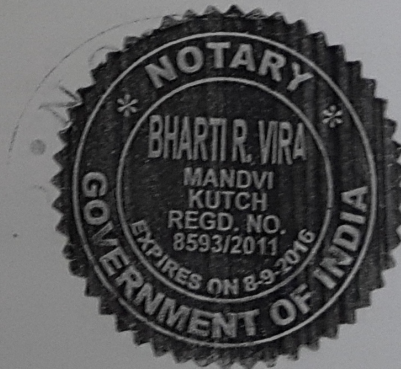

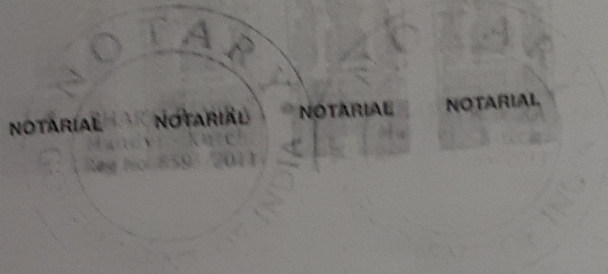

Sub: Regarding granting of permission for Private Primary School.

Dear Sir,

With reference to the above and application by your institution Shree Global Vision International School, Mandvi – Kachchh seeking permission for school and subsequent correspondence and verification of details, your proposed school expected to start functioning from June, 2015, is granted permission to commence Standard 1 to 5 in Primary Section and Standard 6 to 8 in higher Primary Section with English medium subject to fulfillment of below mentioned conditions/stipulations:

- (1) At the time of admission, school governing body or school shall not ask for any capitation fees, donations, deposits etc. nor shall they conduct any interviews of the parents or students.
- (2) Any child shall not be denied admission in the school in absence of any proof of age nor shall admission be denied on the basis of any of the reasons for cast, creed or place of birth.
- (3) School shall have to ensure that any child admitted in the school shall not be detained in a class nor shall be expelled from the class or school till completion of Primary education. No child shall be subjected to physical punishment or mental harassment. Child shall not have to appear in any Board examination till completion of Primary education. Every student completing Primary education shall have to be given a certificate to that effect. Teachers fulfilling qualification norms in terms of Bombay Primary Education Regulations 1947 and Bombay Primary Education Rules 1949 shall only be appointed as Teachers. None of the teachers of the school shall involve in activities related with private coaching/tuitions.
- (4) The School shall have to follow study course/syllabus as prescribed by the Competent Educational Authority decided by the State Government.
- (5) School shall admit only that many students for whom the school has sufficient infrastructure facilities.
- (6) No type of unauthorized classes shall be conducted/held in the school nor shall the school conduct/hold such unauthorized classes at different venue with same name and style.
- (7) School premises, ground or any other infrastructural facilities shall be used only for educational and skill developmental activities. Society registered under the Society Registration Act, 1860 or such other rules shall only operate the school.
- (8) Any individual or association or group of individuals shall not operate the school with the profit motive.

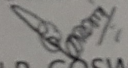
- (9) Financial accounts of the school shall have to be get audited by Chartered Accountant and a certificate to that effect with due statement certificate shall have to be obtained and a copy thereof shall have to be submitted to the District Primary Education Officer or District Education Officer.
- (10) School shall have to furnish all details that may be demanded by the District Primary Education Officer or District Education Officer, State Government or Local Institutions for fulfillment of conditions or for removal/redressal of lapses therein
- (11) Failure to comply with the above terms and conditions shall result in to cancellation of permission granted.
- (12) All regulations and rules of RTE-2009 and 2012 shall have to be strictly observed/complied with.
